



Restaurant 360 Privacy Policy

Restaurant 360 is committed to protecting your right to personal privacy and takes these responsibilities very seriously. This following policy explains how we use customer data and how we protect your privacy.

PERSONAL INFORMATION

Personal information is only collected via two methods: The reservation form and purchase of the gift voucher. We never share these personal details with any third parties, unless required to do so by law, and you will only ever be contacted with relevant information about Restaurant 360.

1. By making a reservation and purchase of the gift voucher

When making a reservation or using forms on the website it is necessary to have information in order to identify you, contact you and to process your purchase and requests. This usually includes your name, address, phone number, e-mail address, credit card number and expiration date.

2. By communicating with us regarding service including any profiles, preferences or special requests you may make. By registering or otherwise entering information on or through our website.

Our website does not collect personally identifiable information from you or your computer when you simply visit (e.g., browse) and unless you actually provide us with personally identifiable information, we will not know or collect your name, your e-mail address or any other personally identifiable information about you. When you a request or visit a page on our website, we do log certain communications, technical and operational information and aggregate it with other similar information in order to make our website function correctly, do capacity and other technical planning and generally make our website function properly and improve it where we can. We also use this information to better understand how visitors use our website and how we can better tailor our website, its contents and functionality to meet your needs.

WHEN DO WE DISCLOSE PERSONAL INFORMATION

1 Personal information may be shared internally so that they may provide the services you have reserved.

2. Personal information may be shared with a person who, in the reasonable judgment of the restaurant, is acting on your behalf of or as your agent - for example, a travel agent, secretary or corporate travel department, making a reservation for you.

3. Personal information may be shared with a third party involved in processing transactions you request and supplying you with services.

4. Personal information may be shared with a third party to perform functions, process transactions or provide goods or services to you, such as reservations handling, data processing or storage, surveys or research, to evaluate a customer's credit worthiness or in order to collect a customer's account.



5. Personal information may be shared with a public authority or official or those acting under government or judicial authority to protect the assets and operations of the restaurant or if, in the reasonable judgment of the restaurant, it appears that there may be danger to life, property or public safety which could be avoided or minimized by disclosure of the information, or which disclosure is required by law or regulation.
